In order to be licensed as a Motor Vehicle Emission Inspector, an applicant must complete an approved training program that provides a detailed understanding of inspection related issues. NJGCA is proud to offer a course that is comprehensive and fulfills all state requirements. Our course curriculum includes an overview of state rules and regulations as they pertain to inspection and various emission repair issues. Technicians will be required to pass both a Written and Hands-On exam. Technicians passing these exams will be certified and licensed as Motor Vehicle Emission Inspectors (INL license holder).

#### • Application deadline is NOVEMBER 9, 2020 at 12 Noon.

- Students are only registered for a training session once a complete Application is received (which includes a copy of student's driver's license), payment is made, *and* you receive an email confirmation. As class space is limited, submission alone does not guarantee registration.
- Per MVC guidance, class sizes are limited to 12 students. All classes are first come, first serve. If a student expresses an interest in a training session, but a completed application is not received, the spot will be given to the next available student.
- To register, please scan the completed three-page Application, making note to sign or initial each page where indicated. The completed Application, along with a scanned copy of the student's Driver's License, are to be emailed together in PDF format to <u>training@njgca.org</u>. If paying by check, a scanned copy of the check must also be submitted with the Application.
- Due to limited office staff hours during the ongoing COVID crisis, no faxed Applications will be accepted at this time. Applications will be accepted via email <u>ONLY</u> at <u>training@njgca.org</u>.

#### **TRAINING DAY PROCEDURES & DETAILS:**

- When you arrive for the start of training, you must bring your actual, physical driver's license.
  - If you have an **out of state driver's license**, you must bring your license <u>AND</u> Six Points of Identification (originals) to class with you.
  - If you need further information on New Jersey's Six Points of Identification, please contact us at <u>training@njgca.org</u> and a fact-sheet will be emailed to you with details.
- Once your in-class training is complete, you will be awarded a Certificate as proof of completion.
- At the end of Day 1, NJMVC will administer a written test. You must earn an 80% on the test.
- At the end of Day 2, you will receive a Certificate for completing your Hands-On Training.

#### **POST-TRAINING INL LICENSING PROCEDURES:**

- After completing your Gasoline Hands-On Training on Day 2, NJMVC will make an appointment to visit you at your place of employment to administer the **Gasoline Hands-On Test**.
  - <u>PLEASE NOTE</u>: When MVC arrives to conduct the Gasoline Hands-On Test, you will need to present your Gasoline Hands-On Training Certificate (as proof that you completed Day 2) and you will need a check payable to NJMVC for \$50 for the license fee.
- If you opt to complete your Diesel Hands-On Training, NJMVC will make an appointment to visit you at your place of employment to administer the **Diesel Hands-On Test**.
  - **PLEASE NOTE:** When MVC arrives to conduct the Diesel Hands-On Test, you will need to present your **Diesel Hands-On Training Certificate** (as proof of completion) and <u>you will need a check payable to NJMVC for \$50</u> for the license fee.
- After receiving your NJ Emissions <u>Gasoline</u> Inspection License via mail, you must get your Biometric Finger Printing done in order to be able to inspect a vehicle. Parsons has CIF Locations available for Biometric Collection:
